## Receive Staff Update

a. Banking and credit services update

Yolo County Sustainability Coordinator Regina Espinoza: Three RFP proposals are currently under review by a panel of representatives from the City of Davis, County of Yolo and City of Woodland. Interviews with the applicants are scheduled for later in June and staff recommendations for RFP award will come back to Board at July 25, 2017 meeting.

b. Update on project schedule and summer meeting schedule
