Background:

- Provide support and consistency to VCE Strategic Plan
- Builds on progress in initial VCE Programs Plan (2019)
- Work has focused on plan design; program research
 - Supported by Programs Task Group (PTG)
- Plan delayed due to other large projects (Winters enrollment, Strategic Plan, etc.)
- Current progress: Plan outline drafted, first VCE survey developed & deployed, research and preliminary analysis of potential programs




Plan Outline Draft

Plan Phases

- Phase 1: Ongoing or to be initiated within the next year
- Phase 2: To be initiated within one to three years
- Phase 3: No defined start date for action, likely longer than two years



Phase 1 Programs: In Progress

- Maintain and Enhance Electric Vehicle (EV) Educational Resources
- Deployment and Promotion of EV Charging Stations
- Maintain and Enhance Educational Energy Efficiency Resources



Phase 2: Programs Under Consideration

- Agricultural Electrification
- Heat Pumps
- All Electric Awards
- EV Rebates for Low-income Customers
- SGIP Assistance



Phase 3: Conceptual Programs

- EV Ride & Drive Events
- Induction Cooking
- Disadvantaged Communities Green Tariff (DAC/GT)
- DC Fast Chargers
- Multi-family Charging
- Ag Pump Electrification, Automation and Resilience
- Battery Storage



First VCE Customer Programs Survey

- Developed with feedback from CAC, Staff, Board
- Electronic Survey (SurveyMonkey)
- Available March 8-April 7, 2021
 - 750 participant limit
- Anonymous; seeks feedback on customers' program priorities/preferences
- Small sample size: not statistically significant
- Programs Survey Distribution Strategy



Staff is tracking where participant found survey

Next Steps

- 1. Incorporate CAC feedback
- 2. Finalize Plan structure
- 3. Analyze/incorporate survey results into program design
- 4. Analyze programs based on feasibility, budget and stakeholder priority
- 5. Vet potential programs with PTG
- 6. Final draft of Programs Plan to CAC for discussion before going to the Board
