### Accomplishments


#### Even Cleaner & Greener than We Promised!

When we launched Valley Clean Energy in June 2018, our goal was to buy the cleanest, greenest electricity we could afford for our customers. We promised a minimum of 42% renewable energy in the mix—higher than the 32% PG&E was providing, but at the same price.

Now that our first year's purchases have been tallied, we found that the overall energy portfolio we purchased actually contained 48% renewable energy (PG&E achieved 39%). That has exceeded our promises, and even our own expectations!

How can our renewable content have exceeded our own expectations? When electricity contracts are negotiated, they specify minimum quantities of renewables of different types that must be delivered. There's also a category called "unspecified" power that can't be fully identified in advance. So while our contracts must meet stated minimums for renewables, that doesn't mean they can't sometimes be higher. In this case, our negotiated contracts met and then exceeded those minimum standards. It's good news for everyone.

## Accomplishments

#### **Early Loan Payback**

Gaining approval for our start-up loans was quite a victory for VCE, allowing us to launch in June 2018—each of our founding members (Yolo County, Woodland and Davis) loaned us \$500,000 to get off the ground. The only thing better than landing those critical loans has been our ability to pay them back early—that's exactly what VCE accomplished this past October. It is with tremendous pride that Tom Stallard, member of Woodland's City Council and Chair of VCE's Board of Directors, announced that VCE has repaid its start-up loans of \$1.5 million far ahead of schedule.

It hasn't been smooth sailing every step of the way, which makes our accomplishment that much more impressive. VCE's Board of Directors continued to make wise decisions that represented the best interest of our customers, while helping us to meet our environmental sustainability goals even sooner.

# Solar NEM Customers— Welcome to the VCE Family


Those who get their electricity through solar panels, whether homeowners or business owners, are often one step ahead of the environmental curve, with similar sustainability goals to VCE. Thousands of solar panel owners throughout Yolo County have been waiting patiently to join VCE—their enrollment was initially delayed, due to unforeseen budgetary constraints. We so appreciate your patience and loyalty, and are happy to announce that starting in January 2020, all residential and commercial customers who installed solar prior to VCE's launch (in June 2018) will now be welcomed to the family. If you own solar panels, you'll be automatically enrolled in our Net Energy Metering (NEM) program during your true-up month.

VCE's NEM program works very much like PG&E's program, with one exciting difference that works in your favor: VCE will pay you more than PG&E for extra energy you generate each month. So if your panels produce more than you need in any given month, that energy will be worth one cent more per kWh than it was with PG&E.

We held two workshops in September and October to help explain the ins and outs of our NEM program to our new customers and solar contractors. If you missed those but need some information, please give us a call or send us a note at: info@ValleyCleanEnergy.com.

If you're a solar panel owner, here's what to expect with the enrollment process. You'll get two notices by US mail to remind you that during your regular true-up month, VCE will enroll you into our NEM program—unless you choose not to participate. We think the higher buy-back rate is one good reason, though supporting our community electricity program has additional benefits to offer. If you're not convinced that VCE is right for you, contact us by email or on the website to ask questions, or to opt out.

# Looking Ahead



### VCE has Bid on the Purchase of PG&E's Assets. What's That all About?

PG&E's recent bankruptcy filing has created a unique opportunity for Valley Clean Energy, as it has for other Community Choice Energy programs in PG&E territory. We may now have an opportunity to take over physical assets of PG&E towards rebuilding a more stable and reliable electricity utility in our service area.

After months of research and review with expert consultants, Valley Clean Energy's Board of Directors voted to act on this opportunity. On October 18, 2019, VCE made a non-binding offer of \$300 million to PG&E for its physical assets in Yolo County. Those include the poles and lines and other electricity assets—but not the high voltage transmission system. VCE's offer is subject to approval by the federal court handling the PG&E bankruptcy case.

Taking over physical assets would allow VCE to become a Yolo-based public utility similar to those existing in Lodi, Roseville, Sacramento (SMUD) and other communities across the state. It would allow VCE to remove shareholder profits while reinvesting in upgraded safety protocols, pursuing its mission to build a safe, efficient and affordable clean energy future.

We have completed the preliminary phase and think this offer makes financial and environmental sense. Next steps are in the hands of the bankruptcy court, and will be reported here. Check the VCE website for updates as they become available, at ValleyCleanEnergy.org.


#### Have You Seen our New Ads?


